## Report of a meeting of the Organising Committee of the Group (Meeting reference 20120227)

#### 20120227/1 Present

Paul Escott (Chair), Ruth Griffin, Mavis King (Vice Chair), Alan Lee, Lynne Spencer, Kenneth Spencer. Apologies were received from Pippa McVeigh. We welcomed Alan Lee to his first meeting of the Organising Committee.

#### 20120227/2 The Residents' Meeting

Everyone agreed that it had been a lively meeting, with much discussion, and that the majority of comments had been positive and constructive.

KAS read the report that he has emailed to everyone.

35 questionnaires had been filled in. However some were incorrectly completed. Alan Lee had volunteered for this committee, and there were several volunteers for sub-groups.

KAS will have the collated results of the questionnaires emailed to everyone very soon.

#### 20120227/3 The Public Meeting

It was agreed that this should be held in May.

Paul wished to have a target list of officials - suggestions included:

Duncan Hames MP; Highways Authority for Wiltshire (an official and an elected person); Wiltshire Council (an elected member and an official); Road Safety Representative; Wiltshire Fire & Rescue; Environment Representative; Planning Representative.

It was stressed that we need elected members as well as officials in order to avoid getting different stories and answers.

It was also suggested that at least two of the campaigning organisations may be approached - 20sPlentyForUs and the Brake organisation were suggested.

The invited participants will be given a brief and some indication of likely questions prior to the meeting. This committee will organise the public meeting; the sub committees are to be separate.

The press will be invited. Melksham Independent News and Wiltshire Times. It was noted that the County Council are now enpowered to decide speed limits (although not on routes managed nationally by the Highways Agency).

Ruth will ask if we could have the use of the Farm Shop again.

There was a felt need for a PA system because of the noisy environment. Lynne will ask the church.
